Search for a management structure

You do not need to be a registered Pātaka Whenua user in order to search and access management structure information.

You can search to find trusts, incorporations, Māori reservations as well as other types, and will be able to find information on:

- the overview of the organisation's management structure,
- members of the management structure,
- · ownership details,
- contact details for the administrator (if available).

You can use the management structure search option if you know either the organisation name, organisation ID, organisation type, district, file reference, state, or a combination of these.

Accessing Pātaka Whenua

Step 1

In your web browser, visit the Māori Land Court website <u>www.māorilandcourt.govt.nz</u> and click the green tab in the top right area labelled "*Pātaka Whenua – our online portal*".

In the Pātaka Whenua portal, use the menu on the left side of the screen to click "Search".

Enter the management structure name (or part of) into the **Organisation Name** box if known. You can also add in any other search criteria information that you know using the provided boxes and drop-down menus.

It is recommended to search with at least the name or ID criteria entered in. Using type, district, or state without a name or ID will find over 500 search results.
